## Mount Mary College Expenses

Estimated expenses are listed below for the 2010/2011 school year. Travel expenses are not included. Your funds must meet or exceed the total amount. Fees are subject to change and a yearly increase between 6 and 10 percent is likely.

a. Tuition and fees	\$21,668 + \$450 student fee = \$22,118 (Nursing program tuition to be determined)
b. Room, meals and living expenses	\$8,556* (If you will not be living on campus, you must submit a signed letter from your host family stating that they will provide room and board for you for the entire time that you are in school.)
c. Books and supplies	\$1,100*
d. Health insurance*	\$1,500* (this is an estimate, exact cost will be available June 2010) *(If you have your own insurance with coverage for U.S., that can be used)
