National Art Therapy Credentials

Mount Mary University's M.S. in Art Therapy with Emphasis in Counseling degree program is accredited through the **Commission on Accreditation of Allied Health Education Programs (CAAHEP)** on the recommendation of the **Accreditation Council for Art Therapy Education (ACATE)** and intended to reflect the required knowledge and skills that a person needs to function as a qualified art therapist.

Students who have graduated from a program accredited by CAAHEP at the time of graduation do not require an education review to be eligible for the **Registered Art Therapist (ATR) credential**.
