Post-Master's Certificate in Clincal Rehabilitation

Graduates earning MMU's Post-Master's Certificate in Clincal Rehabilitation Counseling meet all educational requirements for licensure as a professional counselor (LPC) in the State of Wisconsin. Requirements for licensure outside of WI vary by state and are subject to change. Students are encouraged to identify other states' requirements, which can be found here: https://www.counseling.org/knowledge-center/licensure-requirements/state-professional-counselor-licensure-boards.

Post-Master's Certificate in Clincal Rehabilitation Counseling graduates also meet education requirements to obtain certification as a Certified Rehabilitation Counselor (CRC) through the Commission on Rehabilitation Counselor Certification (CRCC). Students are eligible to take the CRC credentialing exam after 75% of coursework is completed, and thus are able to become fully certified as a CRC immediately upon graduation. The CRC exam is noted as an accepted examination for state counselor licensure in several states, including WI.
