International applicants who wish to enroll as an F-1 visa student must submit statements certifying adequate financial resources. Complete support for the entire first year must be guaranteed. The I-20 form, which is needed to apply for a visa, cannot be issued until you have submitted this form along with an original official bank statement (with currency conversion to U.S. dollars) to the Admission Office at Mount Mary University.

If your funds will come from a private sponsor, a government or other sponsoring agency, they must also sign and certify this form. Signatures certify that you and your sponsors have read this form, that it is a true and complete statement, and that the funds are available and will be provided as indicated. I certify that the information provided is correct and complete and that I will notify Mount Mary University of any change in my financial circumstances.
